The GSL is a Schedule - 'B'/ taken over CPSE in Transport Equipment sector under the administrative control of Department of Defence Production, Ministry of Defence.

Its Registered and Corporate offices are at Vasco Da Gama, Goa.

The authorised and paid up capital of the Company is Rs.60 crores and Rs.58.20 crores respectively as on 31.03.2017.

The shareholding of the Government of India in the company is 51.09%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman Managing Director is the Chief Executive of the Corporation and accountable to its Board of Directors and Government of India. He is responsible for the efficient functioning of the Corporation for achieving its corporate objectives and performance parameters.

III. ELIGIBILITY
