**AMENDMENT-02 TO GUIDELINES OF**  
**DEFENCE TESTING INFRASTRUCTURE SCHEME (DTIS)**

1. Defence Testing Infrastructure Scheme (DTIS) guidelines were issued vide DQA(WP) letter of even number dated 14 May 20 & Amendment-1 to DTIS guidelines was issued vide DQA(WP) letter of even number dated 24 Jul 20.
2. To facilitate setting up of DTIS facilities in Defence Industrial Corridors (DICs), the following amendments are made to the DTIS guidelines: -

(a) **Para 5.2 of DTIS Guidelines.**

For

*“Cost of land is not proposed to be funded under the Scheme. Land for DTIs would be arranged by the Implementation Agency. In case the Implementation Agency is not owner of the land, they should have lease for the land for at least 30 years from the date of response to RFP. Land availability with Implementation Agency shall be essential condition for consideration of applicant’s response”.*

Read

*“Cost of land is not proposed to be funded under the Scheme. Land for DTIs would be arranged by the Implementation Agency. In case the Implementation Agency is not owner of the land, they should have lease for the land for at least 30 years from the date of response to RFP. Land availability with Implementation Agency shall be essential condition for consideration of applicant’s response. **For projects being set up in the State DICs, land can also be provided by the State DIC to the Implementation Agency, as per the prescribed/ agreed upon conditions and modalities”.***

(b) **Para 7.3 of DTIS Guidelines**

For

*“**Request for Proposal** The Staff Qualitative Requirements (SQRs) may be refined after receipt of responses to EoI. For selection of Implementation Agency for execution of each DTI project, Request For Proposal (RFP) may be issued to the shortlisted participants of the EoI who meet the specified criteria”.*

Read

**“Request for Proposal** The Qualitative Requirements (QRs) may be refined after receipt of responses to EoI. For selection of Implementation Agency for execution of each DTI project, Request For Proposal (RFP) may be issued to the shortlisted participants of the EoI who meet the specified criteria. **However, notwithstanding the above EoI process, RFPs prescribing requisite eligibility and other criteria, may also be issued by DDP/ DICs”.**

(c) **Para 8.3 of DTIS Guidelines**

For

“Immediately after registration of SPV (Implementing Agency), the respondent shall inform DDP/DGQA about names of SPV constituents share holding pattern of the SPV and whether they qualify the eligibility criteria. Hereafter, all correspondence shall be made by Government with SPV (Implementing Agency)”.

Read

“Immediately after registration of SPV (Implementing Agency), the respondent shall inform **DIC/DDP/DGQA** about names of SPV constituents share holding pattern of the SPV and whether they qualify the eligibility criteria. Hereafter, all correspondence shall be made by **DIC/Government** with the SPV (Implementing Agency)”

3. These amendments come into force with immediate effect.
