

Monthly Summary for the Cabinet: may 2024 (Unclassified)

- 1.1 During the month of May 2024, Standard Operating Procedure (SOP) and Open General Export Licenses (OGELs) for the export of munitions list items have been modified and placed on the website of Department of Defence Production (DDP). The modifications made are as below:
- The Standard Operating Procedure (SOP) for Defence exports have been further simplified and made business friendly.
 - The scope of Open General Export License (OGEL) has been expanded by increasing the nos. of countries and items. OGELs are now applicable for 41 Wassennar Arrangement countries including Brazil.
- 1.2 In line with India's Defence Export Strategy to enhance defence exports, 108 Export Authorisations were issued to 26 countries during the month, having value of Rs. 483.97 crores by private Companies and Rs. 238.29 crores by DPSUs bringing the total value of export to Rs. 5192.99 crores in FY 2024-25.
- 1.3 A Total of 19 Industrial License applications were disposed of by the Standing Committee on Private sector participation in May 2024.
