I. COMPANY PROFILE

Bharat Electronics Limited (BEL) is a Schedule 'A' Navratna Company, established in 1954 with the administrative jurisdiction of Department of Defence Production, Ministry of Defence. BEL has nine production units in Bangalore, Ghaziabad, Pune, Machilipatnam, Kotdwara, Panchkula, Chennai, Hyderabad and Navi Mumbai. BEL's core deliverables in Defence segment are Radars & Weapon Systems, Sonars, Communication, Electronics Warfare, Electro-Optics and Tank Electronics. In Non- Defence Sector, BEL's product range includes Electronic Voting Machine, Medical Electronics Equipment, Home land security solutions etc. BEL also manufactures C4I systems, avionic products, Security systems etc. With its expertise in radio communication systems, BEL also offers total systems capability on a turnkey basis both for Defence an Non-Defence sector.

BEL is primarily an R&D focused organization with R&D facilities in all nine Units to achieve selfreliance. Around 85% of the Company's turnover is generated through Indigenous technology.

Its Registered and Corporate offices are in Bangalore, Karnataka.

The company employed 8937 regular employees (Executives: 6,430, Non-executives: 2507) as on 31.03.2024.

The authorized and paid up capital of the company was Rs. 750 crores and Rs. 730.98 crores respectively as on 31.03.2024.

The shareholding of the Government of India in the company is 51.14% as on 31.03.2024.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Other Units) is a member of Board of Directors and reports to the Chairman and Managing Director.
