Monthly Summary for the Cabinet: August 2022 (Unclassified)

1.1 In continuous pursuit of self-reliance in defence manufacturing and to minimize imports by Defence Public Sector Undertakings (DPSUs) under Aatmanirbhar Bharat Abhiyan, the third Positive Indigenization List (PIL) of 780 strategically important Line Replacement Units (LRUs)/ Sub-Systems/ Components is notified on 28thAugust 2022 by the Department with timelines beyond which they will only be procured from the domestic industry. Details of these items are available on SRIJAN Portal (www.srijandefence.gov.in).

1.2 DDP, MoD led industry delegation visited Sweden from 24-26 August 2022 to attend the 8th India-Sweden Joint Working Group (JWG) meeting in Stockholm, Sweden, after a long gap of 4 years.

1.3 The 12th edition of DefExpo-2022, an Exhibition on Land, Naval and Homeland Internal Security System is being held from 18th to 22ndOct 2022 (03 Business days and 02 Public days) at Gandhinagar Gujarat. The event will resonate with India@75 with focused attention on Defence exports.

1.4 For the first time, a made-in-India Advanced Towed Artillery Gun (ATAG) howitzer gun was part of the 21-gun salute during the Independence Day celebrating at Red Fort in New Delhi, Delhi. Advanced Towed Artillery Gun System (ATAGs) is a glaring example of successful indigenous design and development by DRDO and industries.
