1.1 During the month, numbers of Export Authorizations issued and Licence applications disposed of by the Department are as under: -

1.2 To promote Ease of Doing Business in Defence exports, the following guidelines/ Standard Operating Procedures (SOPs) were further simplified and notified by the Department:

- (i) Revised EUC Counter-Signing Guidelines: OM No. 04(02)/2022-D(EPC) dated 03.06.2022
- (ii) New OGEL for Major Platforms- Notification No. 1(10)/2018-D(EPC) dated 14.06.2022
- (iii) Expansion of OGELs for Intra Company Transfer of Technology and Parts and Components

1.3 The Export SOPs have been streamlined by including following points: -

- (i) Export of complete systems (Appendix-II items) as SAMPLE for participation in tender shall be processed without consultation of Stakeholders, provided that the exporter holds a valid License for manufacturing the item of export.
- (ii) Cases pertaining to export of items to OEM, imported for participation in demo/display/exhibitions/tenders/RFP/RFQ/NIT in India will be processed without stakeholder consultation.
- (iii) The legitimate export of the parts and components for civil use will be permitted in consultation with MEA.

1.4 Hindustan Aeronautics Limited (HAL)'s township in Hyderabad, converted into Mini Smart City with several new initiatives and amenities, was inaugurated on 9th June 2022. HAL's township in Hyderabad is one of the 53 locations identified to be developed into mini smart cities by Ministry of Housing & Urban Affairs.

1.5 Hon'ble Union Finance Minister virtually inaugurated BEL's Mini Smart Colony at BEL-Bangalore Complex on 9th June, 2022. This project is part of the Azadi Ka Amrit Mahostav celebrations being coordinated by Department of Public Enterprises (DPE) in association with the Standing Conference of Public Enterprises (SCOPE) as part of overall campaign of the Ministry of Finance.
