I. COMPANY PROFILE

Hindustan Aeronautics Limited (HAL) was incorporated on 16.08.1963 under the India Companies Act, 1956 and over the years has evolved into a large Aeronautics Complex in South East Asia. It is the flagship aerospace company of the country with comprehensive skills sets in Design, Development, Manufacture, Maintenance and upgrade of Fighters, Trainers, Helicopters, Transport Aircraft, Engines, Avionic systems and accessories. HAL's major supplies and services are made to Indian Defence Services- IAF, Army, Navy and Coast Guard. The company has also established a foothold in Export in more than 25 countries, having demonstrated its quality and price competitiveness. HAL is a major partner for the space programs of Indian Space Research Organisation (ISRO). It has also diversified into the Manufacture and ROH (Repair & Overhaul) of Industrial & Marine Gas Turbine Engines. The Company has 20 Production Units and 9 R&D Centers spread across the country in seven states and ten geographical locations in India.

HAL is also contributing in the field of Aerospace Technology and Management through the HAL Management Academy located at Bengaluru and by the Technical Training Institutes/ Centers which are co-located at the respective geographical locations. The Corporate office of the Company is located at Bengaluru, Karnataka.

HAL is a listed Schedule- 'A' Maharatna CPSE under the Administrative Control of Department of Defence Production, Ministry of Defence.

HAL's Revenue has been growing steadily over the years and during the Financial Year 2023-24, HAL recorded the highest ever Revenue from Operations of Rs. 30,381 Crs. registering a double-digit growth of around 12.8% over the previous Financial Year.

The Company employed 23766 regular employees (Executives: 7466 & Non-Executives: 16300) as on 31.03.2024.

As on 31st March, 2024, the Authorized and Paid-up Capital of the Company were Rs.600Crores and Rs. 334.39 Crores respectively. The President of India is holding around 71.64% Equity Shares in the Company.
