### **EXPRESSION OF INTEREST (EOI)**

## FOR EMPANELMENT OF LEGAL CONSULTANTS FOR DDP, MOD

The Department of Defence Production (DDP) deals with matters pertaining to defence production, indigenization of imported stores, equipment and spares, planning and control of departmental production units of the Ordnance Factory Board and Defence Public Sector Undertakings (DPSUs). It also engages with the private sector licensed for Defence Production and export of various defence related systems, equipment, components etc. Further details of the organization can be obtained from our website http://ddpmod.gov.in.

2. DDP proposes to empanel Legal Firms, for a period of 3 years. Expression(s) of Interest (EOI) are invited from the Legal Consultants /Firms which have adequate experience in dealing with matters pertaining to public policies, legislative enactments, security/defence agreements etc.

#### 3. Duties

The Firm shall be required to perform various activities on a case-to-case basis based on a stipulated TOR. Some of the activities following duties:

- 1) developing a suitable legal framework for robust and secure private sector engagement in the defence sector (for e.g. participation of Licensed Defence
- 2) Undertaking a comparative analysis of defence and security laws of identified jurisdictions contracting with India through bilateral or multilateral instruments
- 3) legal vetting of the industrial security arrangements with the United States of America and other countries
- 4) Perform such other duties of legal nature which may be assigned by DDP

### 4. Eligibility & Qualification Criteria:

The following are the eligibility criteria for submission of EOI:

- 1) The legal Council(s)/ Consultants /Firms shall be well acquainted with the regulatory environment in the defence sector vis-à-vis government and international guidelines and possess relevant experience.
- 2) The legal Council(s)/ Consultants /Firms shall be at least on the panel of any one Central/State/PSU/Autonomous Organization/ Institution.

- 3) The legal Council(s)/ Consultants /Firms shall have adequate legal, administrative and financial capability to undertake the tasks assigned.
- 4) The legal Council(s)/ Consultants /Firms should have completed operation for a minimum of 5 (five) years since its inception/formation.
- 5) Preference will be given to the legal Council(s)/ Consultants /Firms who have dealt earlier with matters pertaining to security and defence related issues.
- 6. The applicant should provide details of successful legal assignments in the Last 03 years to demonstrate experience in providing the legal services in the relevant field.
- 7. Legal Firms to provide a list of all Partners with qualifications along with Revenue earned by the Firm over the last 3 financial years and a certificate to this effect should be submitted from the Auditor of the Firm.
- 8. The Firm shall furnish copies of certificate of registration/ agreement/articles of association, as the case may be, as service firm and PAN, and GST Registration.
- 9. Tenure of Empanelment:

  The initial empanelment will be for six months or until further orders whichever is earlier.
- 10. Firms are required to give their proposals in writing providing their credentials and requests for empanelment with their charges.
- 11. The proposals so received from the legal Council(s)/ Consultants /Firms shall be evaluated on the following criteria. Please note that only those applicant/ firms shall be considered for empanelment that would score a minimum of 70 marks out of 100 marks of the following criteria;
