### I. COMPANY PROFILE

Bharat Dynamics Limited (BDL) was incorporated under the Indian Companies Act, 1956 with the objective of becoming self reliant and globally competitive in high technology aerospace industry. BDL is engaged in manufacturing of sophisticated state-of-art weapons systems for the Armed Forces. BDL is a Schedule "B" / Miniratna CPSE in Medium and Light Engineering sector under the administrative control of Department of Defence Production, Ministry of Defence.

Its Registered and Corporate offices are at Hyderabad, Telangana.

The authorized and paid up share capital of the Company was Rs.125.00 crore and Rs.91.64 crore respectively as on 17th October, 2017.

The shareholding of the Government of India in the company is 100%.

### **II. JOB DESCRIPTION AND RESPONSIBILITIES**

The Chairman and Managing Director is the Chief Executive of the Company and accountable to its Board of Directors and Government/Share holders. He/She is responsible for the efficient functioning of the company, and for achieving its corporate objectives and performance parameters.

#### III. ELIGIBILITY

### 3. QUALIFICATION:

The applicant should be a graduate with good academic record from a recognized University/Institution. Applicants with Technical/MBA qualification will have added advantage.

#### 4. EXPERIENCE:

The applicant should possess adequate experience at a senior level in an organization of repute.

Experience in Finance/Marketing/Production/R&D in Defence sector will have added advantage.

### 5. PAY SCALE/ RANK/ LEVEL:

The minimum length of service required in the eligible scale/rank/level will be one year for internal candidates, and two years for others as on the date of vacancy.

### 6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

#### IV. DURATION OF APPOINTMENT
