 - (iv) Technical support work relating to Electronic System Division in DDP.
 - (v) Examination and render advice on offset proposals related to Electronic Technology.
 - (vi) Represent Department of Defence Production in TEC, TOEC and CNC of projects and various other committees as required.

- (vii) Represents Department of Defence Production in Feasibility Studies/PFT for the 'Make' Projects & TDF Projects and advice on resolving issues while execution of these projects.
- (viii) Maintain close interaction with Indian Navy, Coast Guard, R&D organizations, production agencies, Indian Industries and other organization.

3. Desirable Qualification

Overall performance of the officer must be well above average. Technical Staff Course/PSC Qualification is desirable.
